I. FUNDING OPPORTUNITY DESCRIPTION

A. AGENCY OVERVIEW

The Advanced Research Projects Agency – Energy (ARPA-E), an organization within the Department of Energy (DOE), is chartered by Congress in the America COMPETES Act of 2007 (P.L. 110-69), as amended by the America COMPETES Reauthorization Act of 2010 (P.L. 111-358), as further amended by the Energy Act of 2020 (P.L. 116-260):

- “(A) to enhance the economic and energy security of the United States through the development of energy technologies that—
- (i) reduce imports of energy from foreign sources;
 - (ii) reduce energy-related emissions, including greenhouse gases;
 - (iii) improve the energy efficiency of all economic sectors;
 - (iv) provide transformative solutions to improve the management, clean-up, and disposal of radioactive waste and spent nuclear fuel; and
 - (v) improve the resilience, reliability, and security of infrastructure to produce, deliver, and store energy; and
- (B) to ensure that the United States maintains a technological lead in developing and deploying advanced energy technologies.”

ARPA-E issues this Funding Opportunity Announcement (FOA) under its authorizing statute codified at 42 U.S.C. § 16538. The FOA and any cooperative agreements or grants made under this FOA are subject to 2 C.F.R. Part 200 as supplemented by 2 C.F.R. Part 910.

ARPA-E funds research on, and the development of, transformative science and technology solutions to address the energy and environmental missions of the Department. The agency focuses on technologies that can be meaningfully advanced with a modest investment over a defined period of time in order to catalyze the translation from scientific discovery to early-stage technology. ARPA-E funds transformational research. Existing energy technologies generally progress on established “learning curves” where refinements to a technology and the economies of scale that accrue as manufacturing and distribution develop drive improvements to the cost/performance metric in a gradual fashion. This continual improvement of a technology is important to its increased commercial deployment and is appropriately the focus of the private sector or the applied technology offices within DOE. In contrast, ARPA-E supports transformative research that has the potential to create fundamentally new learning curves. ARPA-E technology projects typically start with cost/performance estimates well above the level of an incumbent technology. Given the high risk inherent in these projects, many will fail to progress, but some may succeed in generating a new learning curve with a projected cost/performance metric that is significantly better than that of the incumbent technology.

ARPA-E funds technology with the potential to be disruptive in the marketplace. The mere creation of a new learning curve does not ensure market penetration. Rather, the ultimate value of a technology is determined by the marketplace, and impactful technologies ultimately become disruptive – that is, they are widely adopted and displace existing technologies from the marketplace or create entirely new markets. ARPA-E understands that definitive proof of market disruption takes time, particularly for energy technologies. Therefore, ARPA-E funds the development of technologies that, if technically successful, have clear disruptive potential, e.g., by demonstrating capability for manufacturing at competitive cost and deployment at scale.

ARPA-E funds applied research and development. The Office of Management and Budget defines “applied research” as an “original investigation undertaken in order to acquire new knowledge...directed primarily towards a specific practical aim or objective” and defines “experimental development” as “creative and systematic work, drawing on knowledge gained from research and practical experience, which is directed at producing new products or processes or improving existing products or processes.”¹ Applicants interested in receiving financial assistance for basic research (defined by the Office of Management and Budget as “experimental or theoretical work undertaken primarily to acquire new knowledge of the underlying foundations of phenomena and observable facts”)² should contact the DOE’s Office of Science (<http://science.energy.gov/>). Office of Science national scientific user facilities (<http://science.energy.gov/user-facilities/>) are open to all researchers, including ARPA-E Applicants and awardees. These facilities provide advanced tools of modern science including accelerators, colliders, supercomputers, light sources and neutron sources, as well as facilities for studying the nanoworld, the environment, and the atmosphere. B. PROGRAM OVERVIEW

1. BACKGROUND

Motivation

The electric vehicle (EV) market is growing rapidly. Although globally, a modest 3% of passenger vehicles on the road are electric, the number is expected to increase to 28% by 2030 and 58% by 2040.³ The EV revolution will be driven primarily by a combination of the following considerations:

- Consumer demand for cleaner vehicles;
- Fluctuations and uncertainties in the price of gasoline;
- Reductions in the price of EVs;
- Emerging legislation that may limit or even prohibit the sale of internal combustion engine vehicles; and
- Financial incentives to purchase EVs in the form of rebates and/or tax credits.

The most critical factor motivating EV adoption by consumers may be more attractive economics made possible by significant reductions in the cost of lithium-ion battery (LIB) packs. Already, prices have decreased from approximately ~\$1,300 per kilowatt-hour (kWh) in 2010 to about \$150/kWh in 2022 and are projected to fall below \$80/kWh by 2030.³ This reduction in pack cost has been achieved through economies of scale, improved manufacturing processes, and the introduction of new battery chemistries that reduce or eliminate the requirement for critical and expensive minerals, particularly cobalt.⁴

Current EV manufacturing practices have been established along a linear economic model of “take, make, use, and dispose” with negligible consideration for battery end of life (EOL). However, significant increases in the number of EVs will be accompanied by large volumes of battery waste, albeit with a 10- to 20-year lag, depending on both the type of battery and conditions of use. The disposal of spent batteries is challenging due to fire hazards and/or potential releases of toxic chemicals into the environment. The existing supply chain for EV batteries relies mostly on recycling to close the loop to recover a fraction of critical minerals. However, conventional battery recycling methods such as pyrometallurgy and hydrometallurgy are energy-intensive, produce significant quantities of greenhouse gases (GHGs), and lead to large volumes of waste deposited in landfills. These approaches require shredding cell modules or whole batteries, and with few exceptions, intentionally recover only the most valuable materials (e.g., nickel, cobalt, and copper). Although direct recycling⁵ is less energy intensive

and has a smaller carbon footprint than pyrometallurgical and hydrometallurgical processes,⁶ it also requires shredding and thus destroys the embedded manufacturing value of spent battery packs and their constituent components.

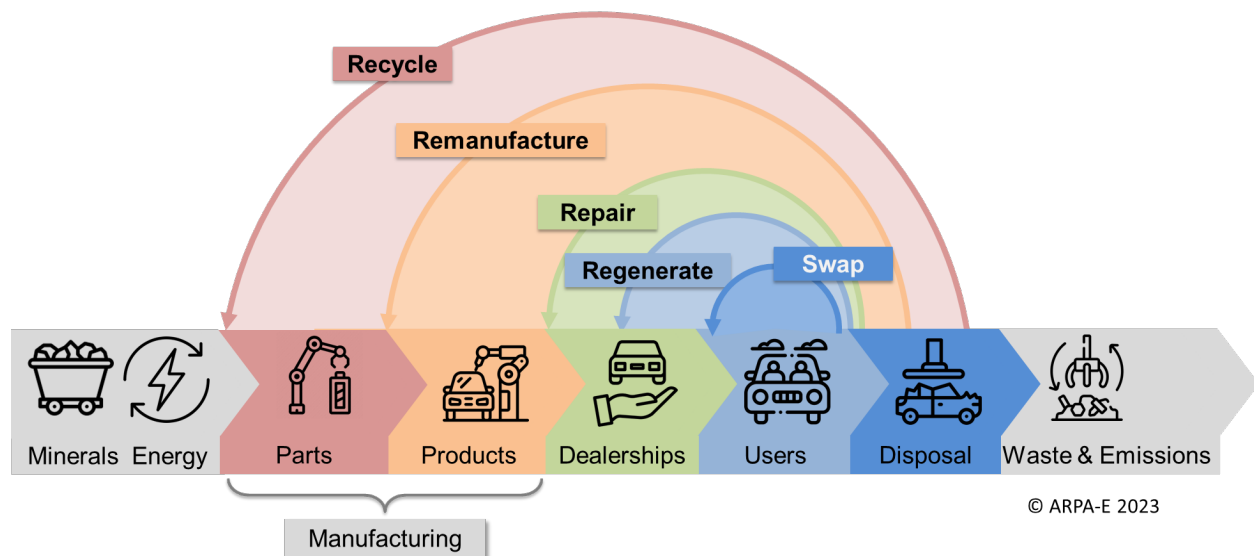


Figure 1. Illustration of the current linear EV supply chain and different strategies to achieve a circular EV battery alternative with recycling as a process of last resort.

These recycling strategies are expected to endure increasingly challenging economics as battery chemistries that rely on more abundant and/or less expensive minerals capture increasingly significant market share. For instance, lithium iron phosphate (LFP) has made inroads into the EV battery market in recent years.³ Prolonging the service life of EV batteries and recovering the manufacturing value of spent batteries to the greatest extent possible through regeneration, repair, reuse, and remanufacture will reduce the demand for critical minerals, as well as the domestic energy burden and the subsequent carbon footprint of the EV battery supply chain. Figure 1 illustrates the different approaches that can be developed to achieve a circular EV battery supply chain including swapping, regenerating, repairing, and remanufacturing. Here, recycling is considered a process of last resort.

Lessons Learned from Lead-Acid Batteries

The supply chain for commercial lead-acid batteries used in ICE vehicles is frequently highlighted as an example of a successful circular supply chain achieved solely through recycling.⁷ First, ninety-nine percent of lead-acid batteries are recycled in the U.S.⁸ This is due in

part to an efficient and incentivized recovery strategy where owners can exchange spent batteries towards the purchase of a new ones at a discounted price. Second, lead-acid batteries use an aqueous electrolyte and electrodes in the form of millimeter thick lead (Pb) and lead oxide (PbO₂) plates. This simple design and chemical composition enable facile separation of electrodes, electrolyte, and plastic casing for recycling.⁹ However, lead-acid battery recycling is an energy intensive process that includes comminution, melt-processing and extrusion of plastics, and smelting of lead-containing components.¹⁰ The practice also raises major concerns over environmental contamination and human exposure to toxic lead.

Effective methods exist for regenerating lead-acid batteries. For example, these batteries may degrade due to lead sulfate (PbSO₄) crystal formation on the Pb electrode during discharge. Upon deep discharge, or if the battery is left discharged for a long time, a hard and thick layer of PbSO₄ can grow and significantly reduce the battery's performance. Several methods have been shown to regenerate Pb electrodes by reversing PbSO₄ formation. Pulse conditioning consists of imposing a high voltage pulse which electrochemically reverses the PbSO₄ formation reactions without causing excessive heating. Alternatively, adding chemicals to the sulfuric acid electrolyte can help remove the PbSO₄ layer.

The supply chain model for lead-acid batteries is difficult to reproduce for LIB packs. For example, LIBs use flammable, reactive, and hazardous organic electrolytes instead of water. They exhibit architectural and compositional complexity of thin film electrodes and have a significantly higher energy content. Despite this, EV batteries may be able to emulate some of the following lead-acid battery design features to promote circularity:

- The ability to swap one battery pack for another;
- The ability to prolong battery life by regenerating electrode materials *in situ* (e.g., pulse conditioning, chemical treatment) and/or by replenishing the electrolyte;
- The simplicity of the materials chemistry, design, and manufacturing which makes batteries easy to disassemble and to separate the anodes, cathodes, electrolyte, as well as casing to facilitate repair, remanufacture, and recycling; and
- The standardization of battery chemistry and form factor.

Technology Needs for a Circular EV Battery Supply Chain

A major shift in conventional thinking and operation is required to realize a truly circular EV battery supply chain with innovations and practices that consider EOL while recognizing the need for recycling as a process of last resort. The following sections briefly discuss examples of materials, designs, and manufacturing strategies that may contribute to the development of a

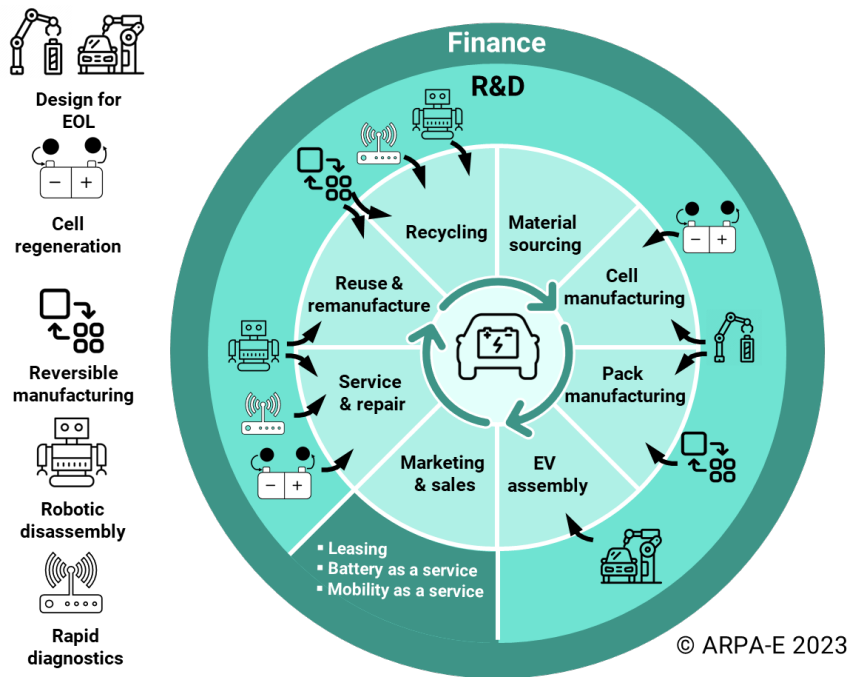


Figure 2. Illustration of the research and development needs and financial strategies that can be deployed along a circular EV battery supply chain.

circular EV battery supply chain. The topics highlighted in the following sections are illustrative examples of potential solutions capable of achieving the Catalyzing Innovative Research for Circular Use of Long-lived Advanced Rechargeables (CIRCULAR) program objectives. Note that there is no preference in favor of these specific approaches nor against other possibilities not explicitly mentioned. Figure 2 depicts the program’s vision of the circular EV supply chain that may be achieved through the innovative technologies and business models discussed in the next sections.

Prolonging Battery Cell Life

Battery degradation may proceed through different chemical pathways depending on the selection of electrode materials, electrolyte compositions, cell designs, and cycling conditions. For example, rapid charging of conventional LIBs in cold temperatures can result in undesired lithium plating and dendrite formation at the graphite anode due to sluggish lithium intercalation and phase transitions. In turn, this phenomenon leads to a loss of active lithium inventory as lithium ions (Li^+) no longer participate in reversible redox reactions. Conceivably, strategies capable of efficiently and cost-effectively limiting degradation mechanisms and/or regenerating battery materials to their beginning of life (BOL) performance are promising options for extending the service life of individual battery cells in support of circularity. Such techniques can be performed *ex situ* or *in situ*, although the latter may be more desirable from an implementation perspective. To date, limited investigative effort has been dedicated to these approaches, which also necessitate innovations in cell design depending on the battery

chemistry and the methods used to prolong battery life. Arguably, cell regeneration would be most valuable for electrode materials that degrade more rapidly than others, including mixed metal oxides of nickel, manganese, cobalt, or aluminum (e.g., NMC or NCA) conventionally used in LIBs. Finally, safety of the redesigned cells during fabrication, operation, and regeneration should be maintained according to current industry standards.

Reversible Manufacturing for Easy Repair, Upgrade, Reuse, and Remanufacture

Battery pack repair and remanufacture promote circularity of the EV battery supply chain through replacement of defective and/or deteriorated components. Within each aging, defective, or spent battery pack there may exist individual salvageable battery cells, modules, and components which could potentially be economically recovered, reused, or recycled, and in all cases removed from waste streams. Reincorporating these salvaged components into new or refurbished battery packs preserves their embedded manufacturing value. A recycling stream consisting of only spent cells would yield black mass with a higher concentration of critical materials and therefore higher recycling value per unit mass. Simple, rapid, and safe disassembly procedures could additionally facilitate rework of defective battery packs during production, and thereby reduce the quantity of scrap generated by gigafactories. Streamlined disassembly could also enable the replacement of aging battery pack components as a preventative measure or to improve performance.

Battery repair may be more intrusive, time consuming, and expensive compared to *in situ* battery regeneration, but could still be performed by qualified technical staff in specialized facilities or dealership service departments. This approach would benefit from a holistic design of EVs and battery packs and a judicious selection of materials and manufacturing methods, which would promote safe and convenient disassembly to access components that are more prone to failure earlier in life, e.g., the battery management system (BMS) or cooling pump.

Representative technical approaches to realize so-called “reversible manufacturing,” which refers to the ability to “unmanufacture” battery packs as rapidly or easily as they are manufactured, include the following:

- Design for Reversible Assembly: Existing battery packs that were not originally designed with the EOL in mind require arduous and time-consuming disassembly processes during recycling. By contrast, sustainable designs would enable individual cells, BMS, thermal management components, etc., to be easily isolated, serviced, reused, replaced, and upgraded. Then, only defective cells and deteriorated components that have reached their EOL would require recycling, instead of shredding entire modules or packs. Moreover, a modular design would make this solution highly scalable.
- High Strength Debondable Adhesives: Adhesives are critical to the safe and reliable operation of EV batteries by ensuring that cells, modules, and other critical pack components can withstand mechanical vibrations and shocks. Successful application of high strength, debondable adhesives with equivalent performance to conventional adhesives used in commercial battery packs would simplify disassembly. In principle, stimuli-responsive systems that react to specific wavelengths of light, ultrasound,

electric and/or magnetic fields, etc., may be leveraged to achieve clean and controlled debonding of battery pack adhesives.

- Reversible Welding and Joining Techniques: Welding is the conventional joining technique employed in battery packs primarily due to its long-term durability, mechanical strength, and low interfacial electrical resistance. Effective and scalable strategies for reversible welding or more generally reversible joining of cells, modules, and other battery pack components would facilitate recovery of individual cells. Battery pack designs that circumvent the requirement for permanent joining, either partially or entirely, would be especially advantageous for separating battery packs into individual components. For example, compression technology could be utilized to reduce the number of permanently bonded components while mitigating the risk that fasteners loosen over time.¹¹

Sustainable designs, innovative materials, and reversible manufacturing techniques can enable the safe and rapid manual disassembly of batteries for repair, reuse, remanufacture, and recycling. A complementary or alternative approach to manual disassembly could rely on autonomous robotic disassembly of battery packs.

Autonomous Robotic Disassembly

Currently, manual disassembly of battery packs into individual modules typically takes several hours due to complex, irreversible designs and manufacturing methods, including welded parts and the use of permanent adhesives that are difficult to remove. The high voltage of EV batteries (400 V to 800 V) is also a major safety concern, complicating manual disassembly even when performed by highly trained technicians. Therefore, robotic disassembly of battery packs may be a promising option to increase safety and throughput and simultaneously reduce the cost of repair, reuse, remanufacturing, and recycling, thereby enabling scalable solutions capable of handling the projected future growth of spent EV battery volumes.

Given the wide variety of battery pack designs and manufacturing methods among EV models and their evolution over time, as well as the potential degradation of battery packs during use (e.g., rusty bolts), robotic disassembly should be able to autonomously select, evaluate, and adapt unmanufacturing processes for each EV battery pack. Such autonomous robotic disassembly systems should have the ability to learn from their own experiences, from those of other robots, or from simulations, videos, or other media. Strategies may also need to be developed to coordinate the disassembly of battery packs cooperatively between robots and humans. This vision could be achieved by leveraging recent advances in artificial intelligence and machine learning, for example. Finally, inspection of the battery pack to determine geometric parameters, aging conditions, and potential defects that could compromise safety may be necessary prior to attempting robotic disassembly. The design and manufacture of battery packs may need to be modified to enable the practical implementation of these approaches.

Rapid State of Health Diagnostics

Quantifying the state of health (SOH) and remaining useful life (RUL) of individual cells or modules either continuously during operation within the battery pack, at specific times during repair, and/or at EOL at the pack- or cell-levels, is critical for deciding whether cells should be regenerated, reused/repurposed, or recycled.^{12,13} Such determinations must be made rapidly and reliably and be capable of diagnosing a wide variety of commercial battery cell chemistries and form factors. Relying on traditional electrochemical methods that require several hours to charge and discharge cells at slow rates is impractical for determining SOH and RUL, especially considering the anticipated future volume of spent EV batteries. Several rapid diagnostic techniques have been explored including, but not limited to, electrochemical impedance spectroscopy measurements and ultrasound techniques¹⁴ both combined with physics-based models, data-driven models, and artificial intelligence.^{12,13,15} Finally, SOH, RUL, and other diagnostics performed during normal EV operation could be used to inform the BMS in performing restorative measures to prolong the life of individual cells and/or modules, thus achieving the circularity objectives.¹⁶

Overall, there is a critical need for technological innovations that can be both practically and economically implemented at commercially relevant scales to achieve a circular EV battery supply chain. A diverse array of solutions could be adopted separately, in combination with others, and/or at different times or stages along the battery supply chain. It is expected that introducing new materials and sensing methods, leveraging cell-level life-prolonging strategies, envisioning innovative cell and pack designs, and adopting new reversible manufacturing methods will be challenging for industry, since implementation will likely lower yield and increase capital expenses, at least initially. Despite short-term economic barriers, there is an immediate and critical need to accelerate development of enabling technologies and solutions to catalyze the transition from a linear to a circular supply chain for domestic EV batteries. Chemistry-agnostic technologies are particularly relevant given the current and future diversity of EV battery chemistries.

C. PROGRAM OBJECTIVES

According to the U.S. Environmental Protection Agency (EPA),¹⁷ a circular economy “refers to an economy that uses a systems-focused approach and involves industrial processes and economic activities that are restorative or regenerative by design, enables resources used in such processes and activities to maintain their highest value for as long as possible, and aims for the elimination of waste through the superior design of materials, products, and systems.” Further, “a circular economy reduces material use, redesigns materials, products, and services to be less resource intensive, and recaptures ‘waste’ as a resource to manufacture new materials and products.” Successfully achieving a circular economy requires implementing the above principles to the supply chains of numerous products.

Specifically, creating a circular EV battery supply chain focuses on optimizing the full vehicle life cycle. Thus, the emphasis must shift from production and sales within an ownership model to a model focusing on customers’ mobility needs and access in the form of leasing, as it exists today, vehicle-on-demand (e.g., Zipcar®), and mobility-on-demand (e.g., robotaxis).¹⁸ These different business models may coexist but will require increasing collaboration and transparency among different actors, while costs and revenues will be distributed across the supply chain.

A circular supply chain offers new revenue streams and business opportunities¹⁸ by providing services to maximize EVs’ lifetime performance through:

- Enhancing regular predictive maintenance;
- Repairing and remanufacturing of battery modules and packs;
- Improving the reuse and recovery of EOL parts and materials; and
- Minimizing carbon footprint and maximizing resource efficiency.

A circular supply chain also offers opportunities to reduce production and operating costs¹⁸ by:

- Improving the quality and stability of critical minerals’ supply chains through cell regeneration, reuse, and recycling;
- Facilitating rework, reuse, repair, and remanufacture of batteries through modular designs, reversible manufacturing materials and methods; and
- Reducing asset costs per unit amount of energy delivered owing to the retention of the embedded manufacturing value of batteries, their prolonged lifetime, and the extended use of EVs.

The overarching goal of the CIRCULAR program is to successfully translate the above definition of a circular economy to the domestic EV battery supply chain by supporting the development of innovative solutions that can overcome both the technological and economic barriers to broad commercial adoption. CIRCULAR acknowledges that simultaneous advancements in

multiple technological domains may be required to accomplish this ambitious objective. Therefore, the program is intentionally structured into four technology development categories designed to converge towards the creation of a domestic circular supply chain for EV batteries (Section I.D).

The CIRCULAR program recognizes that conventional recycling is not the only, nor primary, pathway to closing the supply chain loop. Therefore, the primary objective of this program is to catalyze the creation of a circular EV battery supply chain in North America. The program will support the development and deployment of foundational technologies capable of maintaining materials and products in circulation at their highest level of performance and safety for as long as possible. Achieving this goal will directly impact ARPA-E mission areas as follows:

- **Decrease Energy-Related Imports:** The CIRCULAR program aims to reduce the import of critical battery materials, cells, packs, and EVs by establishing new supply chain loops within the U.S. Currently, individual steps in the battery supply chain (mining, material processing, cell component assembly, battery cell manufacturing, and recycling) are concentrated mostly outside of the U.S.
- **Reduce Emissions:** The CIRCULAR program aims to decrease the domestic energy burden and carbon footprint of the EV battery supply chain by extending the service life of battery cells and packs and by maintaining manufacturing value to the greatest extent possible through regeneration, repair, reuse, and remanufacture. The program will also reduce emissions associated with battery recycling by minimizing the amount of waste and by recycling only pack components that have reached their EOL.
- **Improve Energy Efficiency:** The CIRCULAR program aims to minimize energy and material consumption within the battery supply chain and to exploit opportunities to improve energy efficiency through innovative battery design, material regeneration, and/or manufacturing strategies.

D. TECHNICAL CATEGORIES OF INTEREST

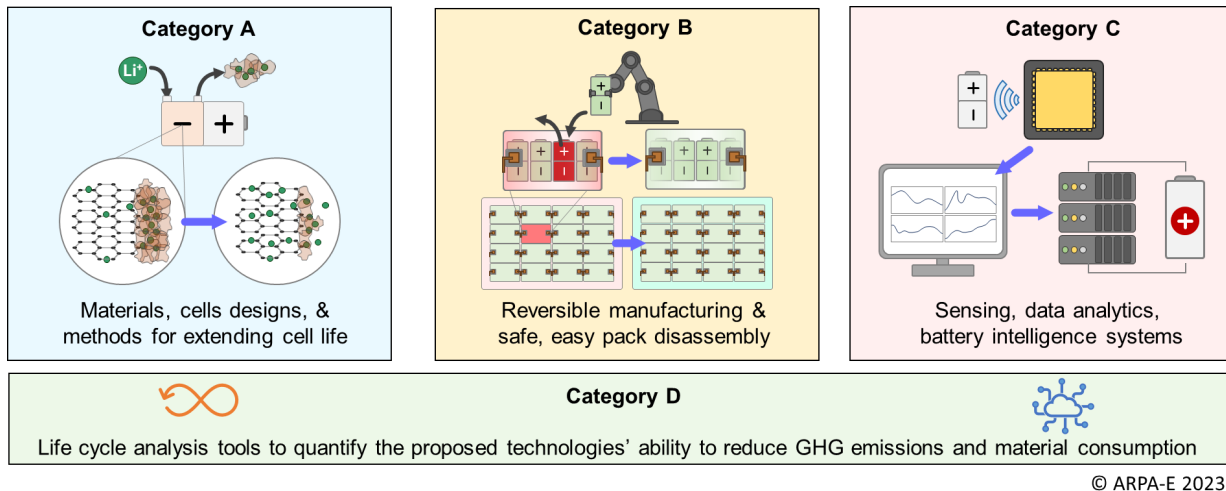


Figure 3. Illustration of the four technical categories of the CIRCULAR program.

The CIRCULAR program is structured into four distinct technical categories, as illustrated in Figure 3. Category A encompasses primarily materials, designs, and regeneration strategies that can be implemented at the battery cell level for the purpose of extending service life. Category B emphasizes innovations at the battery pack level including new materials, designs, and reversible manufacturing techniques to facilitate pack disassembly and recovery of manufacturing value. In addition, autonomous robotic disassembly is highlighted as a practical and economic option to safely manage disassembly operations for large EV battery pack inventories. Category C prioritizes the development and integration of advanced sensing technologies capable of monitoring the SOH of individual cells, associated data analytics, and battery intelligence systems to extend the service life of cells, modules, and packs. Category D focuses on analytical tools to assess the economic benefits of the technologies developed in

Categories A, B, and C, including their impact on GHG emissions and overall material consumption per unit of energy delivered over the lifetimes of battery cells and packs.

Category A is divided into two subcategories, designated A1 and A2, that are defined by discrete ranges for cell-level specific energy density to differentiate among proposed battery chemistries and corresponding technical targets. In subcategory A1, the cell specific energy ranges between 175 to 225 Watt-hours per kilogram (Wh/kg), while in subcategory A2, the cell specific energy is equal to or exceeds 225 Wh/kg. Note that, despite differences in specific energies, circularity metrics for both subcategories aim to achieve the same total amount of energy delivered over the cell lifetime. Category A seeks innovations in battery cell materials, designs, regeneration methods, and corresponding manufacturing techniques to prolong battery service life including, but not limited to, the following:

- Methods and apparatuses to limit degradation of cell performance;
- Battery materials amenable to *in situ* regeneration;
- Regeneration methods and/or operations to cost-effectively restore cells to BOL performance and safety; and
- Cell designs that enable implementation of regeneration methods at scale.

Category B seeks innovations in battery pack designs, materials, and reversible manufacturing methods as well as fast and safe disassembly techniques to recover manufacturing value of cells and pack components including, but not limited to, the following:

- Battery pack designs and reversible manufacturing techniques to facilitate battery pack disassembly to the cell-level;
- Materials and methods to enable reversible manufacturing (e.g., debondable adhesives or reversible joining methods); and
- Autonomous robotic disassembly of battery packs.

Category C seeks innovations in cell-level sensing, data analytics, and battery intelligence systems for circularity and safety including, but not limited to, the following:

- Sensing methods for rapid SOH and RUL determination of individual cells during operation and/or at EOL;
- Seamless and cost-effective integration of sensors during cell (Category A) and pack (Category B) manufacturing;
- Data analytics and battery intelligence systems to enable predictive maintenance and/or to extend the service life of cells, modules, and packs;
- Data-driven guidance to determine the fate of individual cells, i.e., regeneration, repair, reuse, or recycling; and
- Advanced diagnostic tools and techniques to identify damaged and potentially hazardous cells.

Category D seeks to develop analytical tools capable of quantifying the impact of the program's advancements to both justify the adoption of these technologies and inform new business models and opportunities. ARPA-E anticipates supporting one or two teams in this category to develop the technoeconomic, lifecycle, and circularity analysis tools and metrics required to accomplish the following:

- Quantify the capability of proposed technologies to reduce material consumption, energy use, and GHG emissions per kWh delivered throughout the life of a battery pack; and
- Understand and quantify the impact of individual and combinations of proposed technologies on production and operating costs of battery cells, packs, and EVs, to both guide development and build a compelling value proposition to motivate adoption.

Analytical tools should be designed and developed in concert with other teams in the CIRCULAR program. Educational materials (e.g., video), user manuals, and plans for promoting the platform's use and continued support beyond the life of the CIRCULAR program should be created. Applicants must include a plan to achieve the long-term goal of maintaining the public availability of the tools and the ancillary materials necessary to enable use of the tools.

Examples of technologies specifically of interest to the CIRCULAR program, either as standalone solutions or in combination include, but are not limited to, the following:

- Materials and methods to limit degradation of cell performance during cycling under realistic conditions (e.g., temperature, C-rate);
- Battery materials and cell designs amenable to *in situ* regeneration methods;
- Regeneration techniques and protocols to efficiently and cost-effectively minimize performance degradation, prolong life, and/or restore battery cells to BOL performance and safety;

- Designs and reversible manufacturing materials and methods to facilitate battery module/pack disassembly and recovery of manufacturing value;
- High strength debondable adhesives, including stimuli-responsive systems;
- Techniques and designs for reversible joining of battery cells, modules, or packs that do not compromise performance, structural/mechanical integrity, or safety;
- Battery pack designs amenable to rapid disassembly;
- Robotic systems capable of disassembling battery packs, in parts or in full, with the ability to learn autonomously and/or cooperate with humans;
- Sensor platforms and methodologies capable of rapid SOH determination for individual battery cells during use and/or at the end of battery pack life to determine whether cells should be regenerated, reused, or recycled;
- Seamless and cost-effective integration of sensors in manufacturing of battery cells and packs to support circularity objectives;
- Battery intelligence systems and data analytics to extend the service life of cells, modules, and packs, and to determine the fate of cells and other components at EOL.

E. TECHNICAL PERFORMANCE TARGETS

The primary technical and cost metrics for Categories A, B, C, and D of the CIRCULAR program are summarized in Tables 1, 2, 3, and 4, respectively. Additional details, including definitions of individual metrics, are provided in the section below each table.

Note this is a cell-level value (not materials-level) and therefore considers all functional materials, components, and packaging. Achievable value for cell-level specific energy can be calculated based on a cell larger than the 1 Ah capacity cell required for testing during this project. Additional clarification on test protocols is available from the United States Advanced Battery Consortium (USABC) procedure.¹⁹ Battery chemistries that have a pathway to achieving a cell-level specific energy at BOL ≥ 175 Wh/kg are appropriate options for Category A. is included in the table as a reference, it is not intended to convey a preference or requirement for any particular battery chemistry.

- [b] Battery chemistry is selected and disclosed by the applicant. Applicant should identify and, as appropriate, provide descriptions of the anode, cathode, and electrolyte (organic or aqueous liquid, solid-state, etc.).
- [c] Number of cycles to 80% capacity relative to BOL capacity for a new cell; cycling tests performed according to USABC protocols. Applicants should note that the target value for the “Initial Number of Cycles” metric is dependent on the original specific energy for new cells. Cycle life projections based on validated accelerated testing protocols and/or extrapolation from a combination of experimental cycling data and calculated degradation rates may be considered in lieu of an experimentally proven number of initial cycles target requirement.
- [d] BOL capacity of a cell used to confirm effectiveness of cell regeneration strategy; smaller capacity cells may be used for proof-of-concept initially; cell design/form factor must be amenable to the regeneration process.
- [e] New cells featuring a proposed chemistry must show a pathway to passing industry standard cell safety tests,^{20, 21} although it is understood that constraints may exist on organizational capabilities to conduct safety testing either internally or externally through third parties. Therefore, a discussion of the types and scope of standard safety testing that is planned should be included in the submission and will be discussed during the project negotiations phase for selected projects.
- [f] Number of additional cycles to 80% capacity relative to BOL capacity for a regenerated cell; cycling tests performed according to USABC protocols; cycling rates and all other conditions should be identical to those used for cycle life testing of new cells. Applicants should note that the target value for the “Additional Number of Cycles” metric (≥ 3000 for Subcategories A1 and A2) does not need to be accomplished through a process performed only a single time. Stated alternatively, the 3000 additional cycle requirements can be achieved by multiple regeneration processes, although a minimum number to achieve the target is preferred due to practical and economic factors. Cycle life projections based on validated accelerated testing protocols and/or extrapolation from a combination of experimental cycling data and calculated degradation rates may be considered in lieu of an experimentally shown number of additional cycles target requirement.
- [g] Relative to cost for producing a new cell; cell level costs can be calculated using the Argonne BatPaC model for a 20 Ah cell.²²
- [h] GHG emissions associated with carrying out the required regeneration process(es) to achieve the cycle life target.
- [i] Regenerated cell featuring proposed chemistry must be able to pass standard cell safety tests.

II. AWARD INFORMATION

A. AWARD OVERVIEW

ARPA-E expects to make approximately \$30 million available for new awards, subject to the availability of appropriated funds. ARPA-E anticipates making approximately 10-15 awards under this FOA. ARPA-E may, at its discretion, issue one, multiple, or no awards.

Individual awards may vary between \$500,000 and \$5 million in Federal share.

The period of performance for funding agreements may not exceed 36 months. ARPA-E expects to issue funding agreements in December 2024, or as negotiated.

ARPA-E encourages submissions stemming from ideas that still require proof-of-concept R&D efforts as well as those for which some proof-of-concept demonstration already exists.

Submissions requiring proof-of-concept R&D can propose a project with the goal of delivering on the program metric at the conclusion of the period of performance. These submissions must contain an appropriate cost and project duration plan that is described in sufficient technical detail to allow reviewers to meaningfully evaluate the proposed project. If awarded, such projects should expect a rigorous go/no-go milestone early in the project associated with the proof-of-concept demonstration. Alternatively, submissions requiring proof-of-concept R&D can propose a project with the project end deliverable being an extremely creative, but partial solution. However, the Applicants are required to provide a convincing vision how these partial solutions can enable the realization of the program metrics with further development.

Applicants proposing projects for which some initial proof-of-concept demonstration already exists should submit concrete data that supports the probability of success of the proposed project.

ARPA-E will provide support at the highest funding level only for submissions with significant technology risk, aggressive timetables, and careful management and mitigation of the associated risks.

ARPA-E will accept only new submissions under this FOA. Applicants may not seek renewal or supplementation of their existing awards through this FOA.

ARPA-E plans to fully fund the negotiated budget at the time of award.

B. RENEWAL AWARDS

At ARPA-E's sole discretion, awards resulting from this FOA may be renewed by adding one or more budget periods, extending the period of performance of the initial award, or issuing a new

award. Renewal funding is contingent on: (1) availability of funds appropriated by Congress for the purpose of this program; (2) substantial progress towards meeting the objectives of the approved application; (3) submittal of required reports; (4) compliance with the terms and conditions of the award; (5) ARPA-E approval of a renewal application; and (6) other factors identified by the Agency at the time it solicits a renewal application.

C. ARPA-E FUNDING AGREEMENTS

Through cooperative agreements, other transactions, and similar agreements, ARPA-E provides financial and other support to projects that have the potential to realize ARPA-E's statutory mission. ARPA-E does not use such agreements to acquire property or services for the direct benefit or use of the U.S. Government.

Congress directed ARPA-E to "establish and monitor project milestones, initiate research projects quickly, and just as quickly terminate or restructure projects if such milestones are not achieved."²³ Accordingly, ARPA-E has substantial involvement in the direction of every Cooperative Agreement, as described in Section II.D below.

1. COOPERATIVE AGREEMENTS

ARPA-E generally uses Cooperative Agreements to provide financial and other support to Prime Recipients.²⁴

Cooperative Agreements involve the provision of financial or other support to accomplish a public purpose of support or stimulation authorized by Federal statute. Under Cooperative Agreements, the Government and Prime Recipients share responsibility for the direction of projects.

ARPA-E encourages Prime Recipients to review the Model Cooperative Agreement, which is available at <https://arpa-e.energy.gov/technologies/project-guidance>.

2. FUNDING AGREEMENTS WITH FFRDCs/DOE LABS, GOGOs, AND FEDERAL INSTRUMENTALITIES

Any Federally Funded Research and Development Centers (FFRDC) involved as a member of a Project Team must provide the information requested in the "FFRDC Lab Authorization" and "Field Work Proposal" section of the Business Assurances & Disclosures Form, which is submitted with the Applicant's Full Application.

When a FFRDC/DOE Lab (including the National Energy Technology Laboratory or NETL) is the

lead organization for a Project Team, ARPA-E executes a funding agreement directly with the FFRDC/DOE Lab and a single, separate Cooperative Agreement with another entity on the Project Team. Notwithstanding the use of multiple agreements, the FFRDC/DOE Lab is the lead organization for the entire project, including all work performed by the FFRDC/DOE Lab and the rest of the Project Team.

When a FFRDC/DOE Lab is a *member* of a Project Team, ARPA-E executes a funding agreement directly with the FFRDC/DOE Lab and a single, separate Cooperative Agreement with the Prime Recipient, as the lead organization for the Project Team. Notwithstanding the use of multiple agreements, the Prime Recipient under the Cooperative Agreement is the lead organization for the entire project, including all work performed by the FFRDC/DOE Lab and the rest of the Project Team.

Funding agreements with DOE/NNSA FFRDCs take the form of Work Authorizations issued to DOE/NNSA FFRDCs through the DOE/NNSA Field Work Proposal system for work performed under Department of Energy Management & Operation Contracts. Funding agreements with non-DOE/NNSA FFRDCs, GOGOs (including NETL), and Federal instrumentalities (e.g., Tennessee Valley Authority) will be consistent with the sponsoring agreement between the U.S. Government and the Laboratory. Any funding agreement with an FFRDC or GOGO will have similar terms and conditions as ARPA-E's Model Cooperative Agreement (<https://arpa-e.energy.gov/technologies/project-guidance/pre-award-guidance/funding-agreements>).

Non-DOE GOGOs and Federal agencies may be proposed to provide support to the Project Team members on an applicant's project, through a Cooperative Research and Development Agreement (CRADA) or similar agreement.

3. OTHER TRANSACTIONS AUTHORITY

ARPA-E may use its "other transactions" authority under the America COMPETES Reauthorization Act of 2010 and DOE's other transactions authority as codified at 42 USC §7256(a) and (g) to enter into an other transaction agreement with Prime Recipients, on a case-by-case basis.

ARPA-E may negotiate an other transaction agreement when it determines that the use of a standard cooperative agreement, grant, or contract is not feasible or appropriate for a project.

The federal share of other transactions agreements should meet or exceed \$3,000,000. In general, an other transaction agreement normally requires a minimum cost share of 50%. See Section III.B.2 of the FOA.

D. STATEMENT OF SUBSTANTIAL INVOLVEMENT

ARPA-E is substantially involved in the direction of projects from inception to completion. For the purposes of an ARPA-E project, substantial involvement means:

- Project Teams must adhere to ARPA-E’s agency-specific and programmatic requirements.
- ARPA-E may intervene at any time in the conduct or performance of work under an award.
- ARPA-E does not limit its involvement to the administrative requirements of an award. Instead, ARPA-E has substantial involvement in the direction and redirection of the technical aspects of the project as a whole.
- ARPA-E may, at its sole discretion, modify or terminate projects that fail to achieve predetermined Go/No Go decision points or technical milestones and deliverables.
- During award negotiations, ARPA-E Program Directors and Prime Recipients mutually establish an aggressive schedule of quantitative milestones and deliverables that must be met every quarter. In addition, ARPA-E will negotiate and establish “Go/No-Go” milestones for each project. If the Prime Recipient fails to achieve any of the “Go/No-Go” milestones or technical milestones and deliverables as determined by the ARPA-E Contracting Officer, ARPA-E may – at its discretion - renegotiate the statement of project objectives or schedule of technical milestones and deliverables for the project. In the alternative, ARPA-E may suspend or terminate the award in accordance with 2 C.F.R. §§ 200.339 – 200.343.
- ARPA-E may provide guidance and/or assistance to the Prime Recipient to accelerate the commercialization of ARPA-E-funded technologies. Guidance and assistance provided by ARPA-E may include coordination with other Government agencies and nonprofits²⁵ to provide mentoring and networking opportunities for Prime Recipients. ARPA-E may also organize and sponsor events to educate Prime Recipients about key barriers to the commercialization of their ARPA-E-funded technologies. In addition, ARPA-E may establish collaborations with private and public entities to provide continued support for the development and commercialization of ARPA-E-funded technologies.

III. ELIGIBILITY INFORMATION

A. ELIGIBLE APPLICANTS

This FOA is open to U.S. universities, national laboratories, industry and individuals.

1. INDIVIDUALS

U.S. citizens or permanent residents may apply for funding in their individual capacity as a Standalone Applicant,²⁶ as the lead for a Project Team,²⁷ or as a member of a Project Team. However, ARPA-E will only award funding to an entity formed by the Applicant.

2. DOMESTIC ENTITIES

For-profit entities (which includes large businesses and small businesses), educational institutions²⁸, and nonprofits²⁹ that are incorporated in the United States, including U.S. territories, are eligible to apply for funding as a Standalone Applicant, as the lead organization for a Project Team, or as a member of a Project Team.

FFRDCs/DOE Labs are eligible to apply for funding as the lead organization for a Project Team or as a member of a Project Team that includes institutions of higher education, companies, research foundations, or trade and industry research collaborations, but not as a Standalone Applicant.

State, local, and tribal government entities are eligible to apply for funding as a member of a Project Team, but not as a Standalone Applicant or as the lead organization for a Project Team.

Federal agencies and instrumentalities (other than DOE) are eligible to apply for funding as a member of a Project Team, but not as a Standalone Applicant or as the lead organization for a Project Team.

3. FOREIGN ENTITIES

Foreign entities, whether for-profit or otherwise, are eligible to apply for funding as Standalone Applicants, as the lead organization for a Project Team, or as a member of a Project Team. Foreign entities must designate in the Full Application a subsidiary or affiliate incorporated (or

otherwise formed or to be formed) under the laws of a State or territory of the United States to receive funding. The Full Application must state the nature of the corporate relationship between the foreign entity and domestic subsidiary or affiliate. All work under the ARPA-E award must be performed in the United States. The Applicant may request a waiver of this requirement in the Business Assurances & Disclosures Form, which is submitted with the Full Application and can be found at <https://arpa-e-foa.energy.gov/> (see “View Template Application Documents”). Refer to the Business Assurances & Disclosures Form for guidance on the content and form of the request.

4. CONSORTIUM ENTITIES

Consortia, which may include domestic and foreign entities, must designate one member of the consortium as the consortium representative to the Project Team. The consortium representative must be incorporated in the United States. The eligibility of the consortium will be determined by reference to the eligibility of the consortium representative under Section III.A of the FOA. Each consortium must have an internal governance structure and a written set of internal rules. Upon request, the consortium entity must provide a written description of its internal governance structure and its internal rules to the Contracting Officer (ARPA-E-CO@hq.doe.gov).

Unincorporated consortia must provide the Contracting Officer with a collaboration agreement, commonly referred to as the articles of collaboration, which sets out the rights and responsibilities of each consortium member. This collaboration agreement binds the individual consortium members together and shall include the consortium's:

- Management structure;
- Method of making payments to consortium members;
- Means of ensuring and overseeing members' efforts on the project;
- Provisions for members' cost sharing contributions; and
- Provisions for ownership and rights in intellectual property developed previously or under the agreement.

B. COST SHARING³⁰

Applicants are bound by the cost share proposed in their Full Applications.

1. BASE COST SHARE REQUIREMENT

ARPA-E generally uses Cooperative Agreements to provide financial and other support to Prime Recipients (see Section II.C.1 of the FOA). Under a Cooperative Agreement or Grant, the Prime Recipient must provide at least 20% of the Total Project Cost³¹ as cost share, except as provided

2. INCREASED COST SHARE REQUIREMENT

Large businesses³³ are strongly encouraged to provide more than 20% of the Total Project Cost as cost share. ARPA-E may consider the amount of cost share proposed when selecting applications for award negotiations (see Section V.B.1 of the FOA).

Under an “other transaction” agreement, the Prime Recipient is normally expected to provide at least 50% of the Total Project Cost as cost share. ARPA-E may reduce this cost share requirement, as appropriate.

3. REDUCED COST SHARE REQUIREMENT

ARPA-E has reduced the base cost share requirement for the following types of projects:

- A domestic educational institution or domestic nonprofit applying as a Standalone Applicant is required to provide at least 5% of the Total Project Cost as cost share.
- Project Teams composed exclusively of domestic educational institutions, domestic nonprofits, and/or FFRDCs/DOE Labs/Federal agencies and instrumentalities (other than DOE) are required to provide at least 5% of the Total Project Cost as cost share. Small businesses – or consortia of small businesses – may provide 0% cost share from the outset of the project through the first 12 months of the project (hereinafter the “Cost Share Grace Period”).³⁴ If the project is continued beyond the Cost Share Grace Period, then at least 10% of the Total Project Cost (including the costs incurred during the Cost Share Grace Period) will be required as cost share over the remaining period of performance.
- Project Teams where a small business is the lead organization and small businesses perform greater than or equal to 80% of the total work under the funding agreement (as measured by the Total Project Cost) are entitled to the same cost share reduction and Cost Share Grace Period as provided above to Standalone small businesses or consortia of small businesses.
- Project Teams where domestic educational institutions, domestic nonprofits, small businesses, and/or FFRDCs perform greater than or equal to 80% of the total work under the funding agreement (as measured by the Total Project Cost) are required to provide at least 10% of the Total Project Cost as cost share. However, any entity

(such as a large business) receiving patent rights under a class waiver, or other patent waiver, that is part of a Project Team receiving this reduction must continue to meet the statutory minimum cost share requirement (20%) for its portion of the Total Project Cost.

- Projects that do not meet any of the above criteria are subject to the base cost share requirements described in Sections III.B.1 and III.B.2 of the FOA.

4. LEGAL RESPONSIBILITY

Although the cost share requirement applies to the Project Team as a whole, the funding agreement makes the Prime Recipient legally responsible for paying or ensuring payment of the entire cost share. The Prime Recipient's cost share obligation is expressed in the funding agreement as a static amount in U.S. dollars (cost share amount) and as a percentage of the Total Project Cost (cost share percentage). If the funding agreement is terminated prior to the end of the period of performance, the Prime Recipient is required to contribute at least the cost share percentage of total expenditures incurred through the date of termination.

The Prime Recipient is solely responsible for managing cost share contributions by the Project Team and enforcing cost share obligations assumed by Project Team members in subawards or related agreements.

5. COST SHARE ALLOCATION

Each Project Team is free to determine how much each Project Team member will contribute towards the cost share requirement. The amount contributed by individual Project Team members may vary, as long as the cost share requirement for the project as a whole is met.

6. COST SHARE TYPES AND ALLOWABILITY

Every cost share contribution must be allowable under the applicable Federal cost principles, as described in Section IV.G of the FOA.

Project Teams may provide cost share in the form of cash or in-kind contributions. Cash contributions may be provided by the Prime Recipient or Subrecipients. Allowable in-kind contributions include but are not limited to personnel costs, indirect costs, facilities and administrative costs, rental value of buildings or equipment, and the value of a service, other resource, or third-party in-kind contribution. Project Teams may use funding or property received from state or local governments to meet the cost share requirement, so long as the funding or property was not provided to the state or local government by the Federal Government.

The Prime Recipient may not use the following sources to meet its cost share obligations:

- Revenues or royalties from the prospective operation of an activity beyond the period of performance;
- Proceeds from the prospective sale of an asset of an activity;
- Appropriated Federal funding or property (e.g., Federal grants, equipment owned by the Federal Government); or
- Expenditures that were reimbursed under a separate Federal program.

In addition, Project Teams may not use independent research and development (IR&D) funds³⁵ to meet their cost share obligations under Cooperative Agreements. However, Project Teams may use IR&D funds to meet their cost share obligations under “other transaction” agreements.

Project Teams may not use the same cash or in-kind contributions to meet cost share requirements for more than one project or program.

Cost share contributions must be specified in the project budget, verifiable from the Prime Recipient’s records, and necessary and reasonable for proper and efficient accomplishment of the project. Every cost share contribution must be reviewed and approved in advance by the Contracting Officer and incorporated into the project budget before the expenditures are incurred.

Applicants may wish to refer to 2 C.F.R. Parts 200 and 910, and 10 C.F.R Part 603³⁶ for additional guidance on cost sharing, specifically 2 C.F.R. §§ 200.306 and 910.130, and 10 C.F.R. §§ 603.525-555.

7. COST SHARE CONTRIBUTIONS BY FFRDCs AND GOGOs

Because FFRDCs are funded by the Federal Government, costs incurred by FFRDCs generally may not be used to meet the cost share requirement. FFRDCs may contribute cost share only if the contributions are paid directly from the contractor’s Management Fee or a non-Federal source.

Because GOGOs/Federal Agencies are funded by the Federal Government, GOGOs/Federal Agencies may not provide cost share for the proposed project. However, the GOGO/Agency costs would be included in Total Project Costs for purposes of calculating the cost-sharing requirements of the applicant.

8. COST SHARE VERIFICATION

Upon selection for award negotiations, Applicants are required to provide information and documentation regarding their cost share contributions. Please refer to Section VI.B.3 of the FOA for guidance on the requisite cost share information and documentation.

C. OTHER

1. COMPLIANT CRITERIA

Concept Papers are deemed compliant if:

- The Applicant meets the eligibility requirements in Section III.A of the FOA;
- The Concept Paper complies with the content and form requirements in Section IV.C of the FOA; and
- The Applicant entered all required information, successfully uploaded all required documents, and clicked the “Submit” button in ARPA-E eXCHANGE by the deadline stated in the FOA.

Concept Papers found to be noncompliant may not be merit reviewed or considered for award. ARPA-E may not review or consider noncompliant Concept Papers, including Concept Papers submitted through other means, Concept Papers submitted after the applicable deadline, and incomplete Concept Papers. A Concept Paper is incomplete if it does not include required information. ARPA-E will not extend the submission deadline for Applicants that fail to submit required information and documents due to server/connection congestion.

Full Applications are deemed compliant if:

- The Applicant submitted a compliant and responsive Concept Paper;
- The Applicant meets the eligibility requirements in Section III.A of the FOA;
- The Full Application complies with the content and form requirements in Section IV.D of the FOA; and
- The Applicant entered all required information, successfully uploaded all required documents, and clicked the “Submit” button in ARPA-E eXCHANGE by the deadline stated in the FOA.

Full Applications found to be noncompliant may not be merit reviewed or considered for award. ARPA-E may not review or consider noncompliant Full Applications, including Full Applications submitted through other means, Full Applications submitted after the applicable deadline, and incomplete Full Applications. A Full Application is incomplete if it does not include required information and documents, such as Forms SF-424 and SF-424A. ARPA-E will not extend the submission deadline for Applicants that fail to submit required information and documents due to server/connection congestion.

ARPA-E will not extend the submission deadline for Applicants that fail to submit required information due to server/connection congestion. ARPA-E will review and consider each compliant and responsive Full Application, even if no Reply is submitted or if the Reply is found to be noncompliant.

2. RESPONSIVENESS CRITERIA

ARPA-E performs a preliminary technical review of Concept Papers and Full Applications. The following types of submissions may be deemed nonresponsive and may not be reviewed or considered:

- Submissions that fall outside the technical parameters specified in this FOA.
- Submissions that have been submitted in response to currently issued ARPA-E FOAs.
- Submissions that are not scientifically distinct from applications submitted in response to currently issued ARPA-E FOAs.
- Submissions for basic research aimed solely at discovery and/or fundamental knowledge generation.
- Submissions for large-scale demonstration projects of existing technologies.
- Submissions for proposed technologies that represent incremental improvements to existing technologies.
- Submissions for proposed technologies that are not based on sound scientific principles (e.g., violates a law of thermodynamics).
- Submissions for proposed technologies that are not transformational, as described in Section I.A of the FOA.
- Submissions for proposed technologies that do not have the potential to become disruptive in nature, as described in Section I.A of the FOA. Technologies must be scalable such that they could be disruptive with sufficient technical progress.
- Submissions that are not distinct in scientific approach or objective from activities currently supported by or actively under consideration for funding by any other office within Department of Energy.
- Submissions that are not distinct in scientific approach or objective from activities currently supported by or actively under consideration for funding by other government agencies or the private sector.
- Submissions that do not propose a R&D plan that allows ARPA-E to evaluate the submission under the applicable merit review criteria provided in Section V.A of the FOA.

- Concepts that focus on conventional lead-acid batteries.
- Concepts that focus on existing battery recycling processes, including direct recycling.
- Solutions that focus on incremental improvements in commercial technologies, incremental improvements in control systems for commercial technologies, or incremental improvements in operation or maintenance procedures.

4. LIMITATION ON NUMBER OF SUBMISSIONS

ARPA-E is not limiting the number of submissions from Applicants. Applicants may submit more than one application to this FOA, provided that each application is scientifically distinct.

Small business Applicants that qualify as a “Small Business Concern”³⁷ may apply to only one of the two ARPA-E FOA Acronym FOAs: DE-FOA-0003303 (CIRCULAR), or DE-FOA-000 3324 (CIRCULAR SBIR/STTR)). Small businesses that qualify as “Small Business Concerns” are strongly encouraged to apply under the former (SBIR/STTR FOA). Concept Papers found to be noncompliant or nonresponsive may not be merit reviewed or considered for award. ARPA-E makes an independent assessment of each compliant and responsive Concept Paper based on the criteria and program policy factors in Sections V.A.1 and V.B.1 of the FOA.

ARPA-E will encourage a subset of Applicants to submit Full Applications. Other Applicants will be discouraged from submitting a Full Application in order to save them the time and expense of preparing an application submission that is unlikely to be selected for award negotiations. By discouraging the submission of a Full Application, ARPA-E intends to convey its lack of programmatic interest in the proposed project. Such assessments do not necessarily reflect judgments on the merits of the proposed project. Unsuccessful Applicants should continue to submit innovative ideas and concepts to future FOAs.

3. FULL APPLICATIONS

Applicants must submit a Full Application by the deadline stated in the FOA. Applicants will have approximately 45 days from receipt of the Encourage/Discourage notification to prepare and submit a Full Application. Section IV.D of the FOA provides instructions on submitting a Full Application.

ARPA-E performs a preliminary review of Full Applications to determine whether they are compliant and responsive, as described in Section III.C of the FOA. Full Applications found to be noncompliant or nonresponsive may not be merit reviewed or considered for award. ARPA-E makes an independent assessment of each compliant and responsive Full Application based on the criteria and program policy factors in Sections V.A.2 and V.B.1 of the FOA.

ARPA-E will review and consider each compliant and responsive Full Application, even if no Reply is submitted or if the Reply is found to be non-compliant.

5. PRE-SELECTION CLARIFICATIONS AND “DOWN-SELECT” PROCESS

Once ARPA-E completes its review of Full Applications and Replies to Reviewer Comments, it may, at the Contracting Officer’s discretion, conduct a pre-selection clarification process and/or perform a “down-select” of Full Applications. Through the pre-selection clarification process or down-select process, ARPA-E may obtain additional information from select Applicants through pre-selection meetings, webinars, videoconferences, conference calls, written correspondence, or site visits that can be used to make a final selection determination. ARPA-E will not reimburse Applicants for travel and other expenses relating to pre-selection meetings or site visits, nor will these costs be eligible for reimbursement as pre-award costs.

ARPA-E may select applications for award negotiations and make awards without pre-selection meetings and site visits. Participation in a pre-selection meeting or site visit with ARPA-E does not signify that Applicants have been selected for award negotiations.

6. SELECTION FOR AWARD NEGOTIATIONS

ARPA-E carefully considers all of the information obtained through the application process and makes an independent assessment of each compliant and responsive Full Application based on the criteria and program policy factors in Sections V.A.2 and V.B.1 and the risk analysis in Section VI.B.10 of the FOA. The Selection Official may select all or part of a Full Application for award negotiations. The Selection Official may also postpone a final selection determination on one or more Full Applications until a later date, subject to availability of funds and other factors. ARPA-E will enter into award negotiations only with selected Applicants.

Applicants are promptly notified of ARPA-E’s selection determination. ARPA-E may stagger its selection determinations. As a result, some Applicants may receive their notification letter in advance of other Applicants. Please refer to Section VI.A of the FOA for guidance on award notifications.

- The Concept Paper must not exceed 4 pages in length including graphics, figures, and/or tables.
- The Concept Paper must be submitted in Adobe PDF format.
- The Concept Paper must be written in English.
- All pages must be formatted to fit on 8-1/2 by 11-inch paper with margins not less than one inch on every side. Single space all text and use Times New Roman typeface, a black font color, and a font size of 12 point or larger (except in figures and tables).
- The ARPA-E assigned Control Number, the Lead Organization Name, and the Principal Investigator's Last Name must be prominently displayed on the upper right corner of the header of every page. Page numbers must be included in the footer of every page.
- The first paragraph must include the Lead Organization's Name and Location, Principal Investigator's Name, Technical Category, Proposed Funding Requested (Federal and Cost Share), and Project Duration.

Concept Papers found to be noncompliant or nonresponsive may not be merit reviewed or considered for award (see Section III.C of the FOA).

Each Concept Paper must be limited to a single concept or technology. Unrelated concepts and technologies must not be consolidated into a single Concept Paper.

c. PROPOSED WORK

- Describe the final deliverable(s) for the project and the overall technical approach used to achieve project objectives.
- Discuss alternative approaches considered, if any, and why the proposed approach is most appropriate for the project objectives.
- Describe the background, theory, simulation, modeling, experimental data, or other sound engineering and scientific practices or principles that support the proposed approach. Provide specific examples of supporting data and/or appropriate citations to the scientific and technical literature.
- Describe why the proposed effort is a significant technical challenge and the key technical risks to the project. Does the approach require one or more entirely new technical developments to succeed? How will technical risk be mitigated?
- Identify techno-economic challenges to be overcome for the proposed technology to be commercially relevant.
- Estimated federal funds requested; total project cost including cost sharing.

The Prime Recipient may request a waiver of the \$30,000 cap. Note that, patent costs are considered to be Technology Transfer & Outreach (TT&O) costs (see Section IV.G.8 of the FOA below) and should be requested as such.

4. CONSTRUCTION

ARPA-E generally does not fund projects that involve major construction. Recipients are required to obtain written authorization from the Contracting Officer before incurring any major construction costs.

5. FOREIGN TRAVEL

ARPA-E generally does not fund projects that involve foreign travel. Recipients are required to obtain written authorization from the ARPA-E Program Director before incurring any foreign travel costs and provide trip reports with their reimbursement requests.

6. PERFORMANCE OF WORK IN THE UNITED STATES

ARPA-E strongly encourages interdisciplinary and cross-sectoral collaboration spanning organizational boundaries. Such collaboration enables the achievement of scientific and technological outcomes that were previously viewed as extremely difficult, if not impossible.

ARPA-E requires all work under ARPA-E funding agreements to be performed in the United States. However, Applicants may request a waiver of this requirement where their project would materially benefit from, or otherwise requires, certain work to be performed overseas.

Applicants seeking a waiver of this requirement are required to include an explicit request in the Business Assurances & Disclosures Form, which is part of the Full Application submitted to ARPA-E. Such waivers are granted where there is a demonstrated need, as determined by ARPA-E.

7. PURCHASE OF NEW EQUIPMENT

All equipment purchased under ARPA-E funding agreements must be made or manufactured in the United States, to the maximum extent practicable. This requirement does not apply to used or leased equipment. The Prime Recipients are required to notify the ARPA-E Contracting Officer reasonably in advance of purchasing any equipment that is not made or manufactured in the United States with a total acquisition cost of \$250,000 or more. Purchases of foreign equipment with a total acquisition cost of \$1,000,000 or more require the approval of the Head of Contracting Activity (HCA). The ARPA-E Contracting Officer will provide consent to purchase or reject within 30 calendar days of receipt of the Recipient's notification.

8. TECHNOLOGY TRANSFER AND OUTREACH

ARPA-E is required to contribute a percentage of appropriated funds to Technology Transfer and Outreach (TT&O) activities. In order to meet this mandate, every Project Team must spend at least 5% of the Federal funding (i.e., the portion of the award that does not include the recipient's cost share) provided by ARPA-E on TT&O activities to promote and further the development and eventual deployment of ARPA-E-funded technologies. Project Teams must also seek a waiver from ARPA-E to spend less than the minimum 5% TT&O expenditure requirement.

All TT&O expenditures are subject to the applicable Federal cost principles (i.e., 2 C.F.R. 200 Subpart E and 48 C.F.R. Subpart 31). Examples of TT&O expenditures are as follows:

- Documented travel and registration for the ARPA-E Energy Innovation Summit and other energy-related conferences and events;
- Documented travel to meet with potential suppliers, partners, or customers;
- Documented work by salaried or contract personnel to develop technology-to-market models or plans;
- Documented costs of acquiring industry-accepted market research reports; and
- Approved patent costs.

ARPA-E will not reimburse recipients for TT&O costs considered to be unallowable in accordance with the applicable cost principles. Examples of unallowable TT&O expenditures include:

- Meals or entertainment;
- Gifts to potential suppliers, partners, or customers;
- TT&O activities that do not relate to the ARPA-E-funded technologies;
- Undocumented TT&O activities; and
- TT&O activities unrelated and/or unallocable to the subject award.

9. LOBBYING

Prime Recipients and Subrecipients may not use any Federal funds, directly or indirectly, to influence or attempt to influence, directly or indirectly, congressional action on any legislative or appropriation matters pending before Congress, other than to communicate to Members of Congress as described in 18 U.S.C. § 1913. This restriction is in addition to those prescribed elsewhere in statute and regulation.

Prime Recipients and Subrecipients are required to complete and submit SF-LLL, “Disclosure of Lobbying Activities” (<https://www.gsa.gov/forms-library/disclosure-lobbying-activities>) if any non-Federal funds have been paid or will be paid to any person for influencing or attempting to influence any of the following in connection with your application:

- An officer or employee of any Federal agency,
- A Member of Congress,
- An officer or employee of Congress, or
- An employee of a Member of Congress.

10. CONFERENCE SPENDING

Prime Recipients and Subrecipients may not use any Federal funds to:

- Defray the cost to the United States Government of a conference held by any Executive branch department, agency, board, commission, or office which is not directly and programmatically related to the purpose for which their ARPA-E award is made and for which the cost to the United States Government is more than \$20,000; or
- To circumvent the required notification by the head of any such Executive Branch department, agency, board, commission, or office to the Inspector General (or senior ethics official for any entity without an Inspector General), of the date, location, and number of employees attending such a conference.

11. INDEPENDENT RESEARCH AND DEVELOPMENT COSTS

ARPA-E does not fund Independent Research and Development (IR&D) as part of an indirect cost rate under its Grants and Cooperative Agreements. IR&D, as defined at FAR 31.205-18(a),

includes cost of effort that is not sponsored by an assistance agreement or required in performance of a contract, and that consists of projects falling within the four following areas: (i) basic research, (ii) applied research, (iii) development, and (iv) systems and other concept formulation studies.

ARPA-E's goals are to enhance the economic and energy security of the United States through the development of energy technologies and ensure that the United States maintains a technological lead in developing and deploying advanced energy technologies. ARPA-E accomplishes these goals by providing financial assistance for energy technology projects and has well recognized and established procedures for supporting research through competitive financial assistance awards based on merit review of proposed projects. Reimbursement for independent research and development costs through the indirect cost mechanism could circumvent this competitive process.

To ensure that all projects receive similar and equal consideration, eligible organizations may compete for direct funding of independent research projects they consider worthy of support by submitting proposals for those projects to ARPA-E. Since proposals for these projects may be submitted for direct funding, costs for independent research and development projects are not allowable as indirect costs under ARPA-E awards. IR&D costs, however, would still be included in the direct cost base that is used to calculate the indirect rate so as to ensure an appropriate allocation of indirect costs to the organization's direct cost centers.

12. PROHIBITION ON CERTAIN TELECOMMUNICATIONS AND VIDEO SURVEILLANCE SERVICES OR EQUIPMENT

Per 2 C.F.R. § 200.216, recipients and subrecipients are prohibited from obligating or expending project funds to: (1) procure or obtain; (2) extend or renew a contract to procure or obtain; or (3) enter into a contract (or extend or renew a contract) to procure or obtain equipment, services, or systems that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. As described in Public Law 115–232, section 889, covered telecommunications equipment is telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation (or any subsidiary or affiliate of such entities). Refer to 2 C.F.R. § 200.216 for possible additional prohibitions and limitations.

13. BUY AMERICA REQUIREMENT FOR PUBLIC INFRASTRUCTURE PROJECTS

Projects funded through this FOA that are for, or contain, construction, alteration, maintenance, or repair of public infrastructure in the United States undertaken by applicable recipient types, require that:

- All iron, steel, and manufactured products used in the infrastructure project are produced in the United States; and

- All construction materials used in the infrastructure project are manufactured in the United States.

However, ARPA-E does not anticipate soliciting for or selecting projects that propose project tasks that are for, or contain, construction, alteration, maintenance, or repair of public infrastructure. If a project selected for award negotiations includes project tasks that may be subject to the Buy America Requirement, those project tasks will be removed from the project before any award is issued – i.e., no federal funding or Recipient cost share will be available for covered project tasks.

This “Buy America” requirement does not apply to an award where the Prime Recipient is a for-profit entity.

14. REQUIREMENT FOR FINANCIAL PERSONNEL

ARPA-E requires Small Business or Nonprofit applicants to identify a finance/budget professional (employee or contracted support) with an understanding of Federal contracting and/or financial assistance and cost accounting (including indirect costs, invoicing, and financial management systems) that will support the team in complying with all applicable requirements.

- Identification of techno-economic challenges that must be overcome for the proposed technology to be commercially relevant; and
- Demonstration of awareness of competing commercial and emerging technologies and identifies how the proposed concept/technology provides significant improvement over existing solutions.

(2) *Overall Scientific and Technical Merit (50%)* - This criterion involves consideration of the following:

- The feasibility of the proposed work, as justified by appropriate background, theory, simulation, modeling, experimental data, or other sound scientific and engineering practices;
- Sufficiency of technical approach to accomplish the proposed R&D objectives, including why the proposed concept is more appropriate than alternative approaches and how technical risk will be mitigated;
- Clearly defined project outcomes and final deliverables; and
- The demonstrated capabilities of the individuals performing the project, the key capabilities of the organizations comprising the Project Team, the roles and responsibilities of each organization and (if applicable) previous collaborations among team members supporting the proposed project.

3. ARPA-E SUPPORT CONTRACTORS

By discouraging the submission of a Full Application, ARPA-E intends to convey its lack of programmatic interest in the proposed project. Such assessments do not necessarily reflect judgments on the merits of the proposed project. The purpose of the Concept Paper phase is to save Applicants the considerable time and expense of preparing a Full Application that is unlikely to be selected for award negotiations.

compensation of each Subrecipient's five most highly compensated executives. Please refer to <https://www.fsr.gov/> for guidance on reporting requirements. Prime Recipients are required to keep the FSR data current throughout the duration of the project.

ARPA-E may not execute a funding agreement with the Prime Recipient until it has obtained a UEI and completed its SAM and FSR registrations.

Finally, Prime Recipients are required to register with FedConnect in order to receive notification that their funding agreement has been executed by the Contracting Officer and to obtain a copy of the executed funding agreement. Please refer to <https://www.fedconnect.net/FedConnect/> for registration instructions.

2. NATIONAL POLICY ASSURANCES

Project Teams, including Prime Recipients and Subrecipients, are required to comply with the National Policy Assurances attached to their funding agreement in accordance with 2 C.F.R. § 200.300. Refer to Attachment 6 of ARPA-E's Model Cooperative Agreement (<https://arpa-e.energy.gov/technologies/project-guidance/pre-award-guidance/funding-agreements>) for information on the National Policy Assurances.

3. PROOF OF COST SHARE COMMITMENT AND ALLOWABILITY

Upon selection for award negotiations, the Prime Recipient must confirm in writing that the proposed cost share contribution is allowable in accordance with applicable Federal cost principles.

The Prime Recipient is also required to provide cost share commitment letters from Subrecipients or third parties that are providing cost share, whether cash or in-kind. Each Subrecipient or third party that is contributing cost share must provide a letter on appropriate letterhead that is signed by an authorized corporate representative.

4. COST SHARE PAYMENTS³⁹

All proposed cost share contributions must be reviewed in advance by the Contracting Officer and incorporated into the project budget before the expenditures are incurred.

The Prime Recipient is required to pay the "Cost Share" amount as a percentage of the total project costs in each invoice period for the duration of the period of performance. Small Businesses should refer to Section III.B.3 of the FOA.

ARPA-E may deny reimbursement requests, in whole or in part, or modify or terminate funding agreements where Prime Recipients (or Project Teams) fail to comply with ARPA-E's cost share payment requirements.

5. ENVIRONMENTAL IMPACT QUESTIONNAIRE

By law, ARPA-E is required to evaluate the potential environmental impact of projects that it is considering for funding. Prime Recipients must show how any budgeted Technology Transfer and Outreach (TT&O) costs relate to furthering elements of the Technology-to-Market Plan. During the period of performance, Prime Recipients are required to provide regular updates on the initial Technology-to-Market plan and report on implementation of Technology-to-Market activities. Prime Recipients may be required to perform other actions to further the commercialization of their respective technologies.

ARPA-E may waive or modify this requirement, as appropriate.

7. INTELLECTUAL PROPERTY AND DATA MANAGEMENT PLANS

ARPA-E requires every Project Team to negotiate and establish an Intellectual Property Management Plan for the management and disposition of intellectual property arising from the project. The Prime Recipient must submit a completed and signed Intellectual Property Management plan to ARPA-E within six weeks of the effective date of the ARPA-E funding agreement. The Contractor will include this paragraph in all subawards/contracts, regardless of tier, for experimental, developmental or research work.

- All other parties: The federal Non-Nuclear Energy Act of 1974, 42 U.S.C. 5908, provides that the government obtains title to new subject inventions unless a waiver is granted (see below):
 - Class Patent Waiver for Domestic Large Businesses: DOE has issued a class patent waiver that applies to this FOA. Under this class patent waiver, domestic large businesses may elect title to their subject inventions similar to the right provided to the domestic small businesses, educational institutions, and nonprofits by law. In order to avail itself of the class patent waiver, a domestic large business must agree to the U.S. Competitiveness Provision in accordance with Section VI.B.8. of this FOA.

1. GOVERNMENT USE LICENSE

The U.S. Government retains a nonexclusive, nontransferable, irrevocable, paid-up license to practice or have practiced for or on behalf of the United States any subject invention throughout the world. This license extends to contractors doing work on behalf of the Government.

2. MARCH-IN RIGHTS

The U.S. Government retains march-in rights with respect to all subject inventions. Through “march-in rights,” the Government may require a Prime Recipient or Subrecipient who has elected to retain title to a subject invention (or their assignees or exclusive licensees), to grant a license for use of the invention. In addition, the Government may grant licenses for use of the subject invention when Prime Recipients, Subrecipients, or their assignees and exclusive licensees refuse to do so.

The U.S. Government may exercise its march-in rights if it determines that such action is necessary under any of the four following conditions:

- The owner or licensee has not taken or is not expected to take effective steps to achieve practical application of the invention within a reasonable time;
- The owner or licensee has not taken action to alleviate health or safety needs in a reasonably satisfactory manner;
- The owner has not met public use requirements specified by Federal statutes in a reasonably satisfactory manner; or
- The U.S. Manufacturing requirement has not been met.

C. RIGHTS IN TECHNICAL DATA

Data rights differ based on whether data is first produced under an award or instead was developed at private expense outside the award.

- Background or “Limited Rights Data”: The U.S. Government will not normally require delivery of technical data developed solely at private expense prior to issuance of an award, except as necessary to monitor technical progress and evaluate the potential of proposed technologies to reach specific technical and cost metrics.
- Generated Data: The U.S. Government normally retains very broad rights in technical data produced under Government financial assistance awards, including the right to distribute to the public. D. PROTECTED PERSONALLY IDENTIFIABLE INFORMATION

Applicants may not include any Protected Personally Identifiable Information (Protected PII) in their submissions to ARPA-E. Protected PII is defined as data that, if compromised, could cause harm to an individual such as identity theft. Listed below are examples of Protected PII that Applicants must not include in their submissions.

- Social Security Numbers in any form;
- Place of Birth associated with an individual;
- Date of Birth associated with an individual;
- Mother's maiden name associated with an individual;
- Biometric record associated with an individual;
- Fingerprint;
- Iris scan;
- DNA;
- Medical history information associated with an individual;
- Medical conditions, including history of disease;
- Metric information, e.g., weight, height, blood pressure;
- Criminal history associated with an individual;
- Ratings;
- Disciplinary actions;
- Performance elements and standards (or work expectations) are PII when they are so intertwined with performance appraisals that their disclosure would reveal an individual's performance appraisal;
- Financial information associated with an individual;
- Credit card numbers;
- Bank account numbers; and
- Security clearance history or related information (not including actual clearances held).

The U.S. Government is not liable for the disclosure or use of unmarked information and may use or disclose such information for any purpose.

J. EXPORT CONTROL INFORMATION

IX. GLOSSARY

Applicant: The entity that submits the application to ARPA-E. In the case of a Project Team, the Applicant is the lead organization listed on the application.

Application: The entire submission received by ARPA-E, including the Preliminary Application, Full Application, Reply to Reviewer Comments, and Small Business Grant Application (if applicable).

ARPA-E: is the Advanced Research Projects Agency – Energy, an agency of the U.S. Department of Energy.

Cost Sharing: Is the portion of project costs from non-Federal sources that are borne by the Prime Recipient (or non-Federal third parties on behalf of the Prime Recipient), rather than by the Federal Government.

Covered Individual: an individual who contributes in a substantive, meaningful way to the scientific development or execution of an R&D project proposed to be carried out with an award from ARPA-E. This includes, but is not limited to, the PI, Co-PI, Key Personnel, and technical staff (e.g., postdoctoral fellows/researchers and graduate students). ARPA-E may further designate covered individuals during award negotiations or the award period of performance.

Deliverable: A deliverable is the quantifiable goods or services that will be provided upon the successful completion of a project task or sub-task.

DOE: U.S. Department of Energy

DOE/NNSA: U.S. Department of Energy/National Nuclear Security Administration.

FFRDCs: Federally Funded Research and Development Centers

FOA: Funding Opportunity Announcement

Foreign Affiliation: a funded or unfunded academic, professional, or institutional appointment or position with a foreign government or government-owned entity, whether full-time, part-time, or voluntary (including adjunct, visiting, or honorary).

Foreign Countries of Concern: the People's Republic of China, the Democratic People's Republic of Korea, the Russian Federation, the Islamic Republic of Iran, Burma, Eritrea, Pakistan, Saudi Arabia, Tajikistan, and Turkmenistan.

For-Profit Organizations (or For-Profit Entities): Entities organized for-profit that are Large Businesses or Small Businesses as those terms are defined elsewhere in this Glossary.

GOGOs: U.S. Government Owned, Government Operated laboratories.

Institutions of Higher Education (or *educational institutions*): Has the meaning set forth at 20 U.S.C. 1001.

Large Business: Large businesses are entities organized for-profit other than small businesses as defined elsewhere in this Glossary.

Malign Foreign Talent Recruitment Program: the meaning given such term in section 10638 of the Research and Development, Competition, and Innovation Act (division B of Public Law 117–167) or 42 USC 19237, as of October 20, 2022.

Milestone: A milestone is the tangible, observable measurement that will be provided upon the successful completion of a project task or sub-task.

Nonprofit Organizations (or *nonprofits*): Has the meaning set forth at 2 C.F.R. § 200.70.

Prime Recipient: The signatory to the funding agreement with ARPA-E.

PI: Principal Investigator.

Project Team: A Project Team consists of the Prime Recipient, Subrecipients, and others performing or otherwise supporting work under an ARPA-E funding agreement.

Small Business: Small businesses are domestically incorporated entities that meet the criteria established by the U.S. Small Business Administration’s (SBA) “Table of Small Business Size Standards Matched to North American Industry Classification System Codes” (NAICS) (<http://www.sba.gov/content/small-business-size-standards>).

Standalone Applicant: An Applicant that applies for funding on its own, not as part of a Project Team.

Subject Invention: Any invention conceived or first actually reduced to practice under an ARPA-E funding agreement.

Subrecipient: An entity (not an individual) that receives a subaward from the Prime Recipient to carry out part of the ARPA-E award.

Task: A task is an operation or segment of the work plan that requires both effort and resources. Each task (or sub-task) is connected to the overall objective of the project, via the achievement of a milestone or a deliverable.

Total Project Cost: The sum of the Prime Recipient share and the Federal Government share of total allowable costs. The Federal Government share generally includes costs incurred by GOGOs, FFRDCs, and GOCOs.
